



RELEASE AND WAIVER OF LIABILITY AGREEMENT

I acknowledge that I have voluntarily applied to participate in Galactic Camp, 2019, (hereafter "Activity" or "Event") at The USS Hornet Aircraft Carrier (hereafter "Venue"). This event will take place on or between February 23 and February 24, 2019.

I AM AWARE THAT THESE ACTIVITIES ARE INHERENTLY HAZARDOUS AND THAT I COULD BE SERIOUSLY INJURED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

I certify that I am physically fit, have sufficiently prepared or trained for participation in the Activity or Event, and have not been advised by a qualified medical professional to avoid participation. I certify that there are no health-related reasons or problems which preclude my participation in this Activity or Event.

I acknowledge that this Release and Waiver of Liability Agreement will be used by the event holders, sponsors, and organizers of the Activity or Event in which I may participate, and that it will govern my actions and responsibilities at said Activity or Event.

In consideration for admission to and participation in this Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this Event, THE FOLLOWING ENTITIES OR PERSONS: Galactic Camp's organizers, staff and volunteers; the owners of and providers of fixtures, furniture, and accessories for the Event; and the Venue's directors, officers, employees, volunteers, representatives, and agents (hereafter collectively referred to as "Organizers"),

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Organizers from any and all liabilities or claims made as a result of participation in this Activity or Event, whether caused by negligence or otherwise.

I acknowledge that this Activity or Event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to participants, volunteers, spectators, event officials, and event monitors, and/or organizers of the Event, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers. **I recognize these risks, and nevertheless release the Organizers from any and all past, present, or future liability that may arise from this Event.**

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this Activity or Event.

I understand that at this Event or related activities, there is the possibility that I may be photographed. If I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the Event Organizers, holders, producers, and sponsors, then I will sign a model release to be provided by the Organizers.

I understand that this Event is a fursuiting event, and all that this entails, and I agree to the principles of SSC (Safe, Sane, and Consensual) activity, and all that this entails, and agree to adhere to the Event rules. These rules include, but are not limited to, respecting the **privacy** and **confidentiality** of participants during and after the Event ("What happens at Galactic Camp stays at Galactic Camp."). **I have read and understand the rules and regulations of the Venue.**

This Release and Waiver of Liability Agreement shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE EVENT ORGANIZERS AND SIGN IT OF MY OWN FREE WILL.
